 - **MUST** attend 9 of the 12 annual meetings
 - Cost once application is accepted: \$35* per month or \$350* to cover 12 months, payable each month by a date determined by your group. **A CEO Round Table Member commits to paying the required dues of \$35 monthly or the annual \$350, whether they attend the meeting or not. *Some groups may have an additional \$50 annual facility cost.**
